<b>DESCRIPTION:</b>	Event Management for Training of Master Trainees (ToT) for ten Districts of National Health Support Program.

**1. BACKGROUND:**

The Government of Khyber Pakhtunkhwa, Health Department, through the National Health Support Program (NHSP-KP), has received financing from the World Bank to strengthen equitable delivery and improve the quality of essential health services financing at the Primary Health Care (PHC) level in support of Universal Health Coverage (UHC) in Khyber Pakhtunkhwa.

In order to Improve coverage and quality of essential health services, the National Health Support Program (NHSP-KP) Under DLI-2 "PHC providers delivering quality essential health services, including in lagging areas", is carrying out Training of Master Trainee. Under NHSP-KP, the Government of Khyber Pakhtunkhwa is implementing activities under Disbursement Linked Indicator-2 (DLI-2) to enhance the quality of PHC service delivery. A key intervention is the development of Master Trainers across ten (10) districts to support trickle-down capacity building in RMNCH and related areas.

**2. INVITATION FOR QUOTATIONS:**

The National Health Support Program (NHSP-KP) invites sealed quotations under the One-Envelope Procedure from eligible bidders for Event Management for Training of Master Trainee (ToT) for Ten Districts of National Health Support Program. The objective of this procurement is to engage a qualified firm to provide logistic and event management services for the conduct of Training of Trainers (ToT) sessions under NHSP-KP.

The Process will be conducted through RFQ mode as specified in World Bank's Procurement Regulations July 2016, revised November 2017, August 2018, and November 2020 and 2025 applicable to IPF and is open to all eligible offerors as defined in Procurement regulations.

**3. SUBMISSION OF QUOTATIONS:**

The quotation must reach the undersigned not later than 16<sup>th</sup> April 2026 till 11:30 am and will be opened at 12:00 am, in the presence of bidders who choose to attend, at the following address:



**Important Instructions:**

- I. Quotations received after the deadline shall be rejected unopened.
- II. In case of a public holiday, the quotation must be submitted on the next working day at the same time and venue.
- III. Quotations shall be valid for sixty (60) days from the submission deadline.

**TERMS AND CONDITIONS:**

1. The vendor must be registered with the Income Tax Department and appear on the Active Taxpayer List (ATL). All applicable taxes and duties shall be deducted in accordance with prevailing government rules.
2. The bidders must submit an affidavit confirming that the firm is neither blacklisted nor involved in any litigation with the World Bank. Non-submission of required documents shall result in disqualification.
3. The firm shall conduct the event management as per training plan provided by the NHSP. Payment shall be made after for event or training conducted in conjunction with Sign Contract Agreement.
4. Prices shall be quoted in Pakistani Rupees, remain fixed for the contract period, and represent the bidder's best and final offer. No post-bid negotiations on price will be entertained.
5. This procurement shall be governed by the World Bank's Procurement Regulations for IPF Borrowers (latest edition), including provisions related to fraud and corruption.
6. Bidders, suppliers, contractors, and their agents must observe the highest standards of ethics during the procurement process and contract execution. Firms or individuals declared ineligible by the World Bank due to corrupt, fraudulent, collusive, coercive, or obstructive practices shall not be eligible to participate.
7. In the event of any conflict between national procurement rules and World Bank regulations, the World Bank regulations shall prevail.
